



Academic school year 2019/20 Fees and general conditions

1. School year fees :

- 1.1 Included in the fees: Full board (boarding), tuition, continuous supervision and care, taxes, supervised personal homework, sports/arats and cultural workshops (see activity list).
- 1.2 Additional, non-refundable fixed costs payable in advance to secure your child's place at Chantemerle. : CHF 1'500.- (admission fees: CHF 300.-, transport fees: CHF 250.-, material: CHF 700.-, cultural / artistic fees : CHF 250.-).
- 1.3 Additional, personal variable costs (about + 10% of to be deducted from trimestrial deposits with detailed breakdown of costs: private courses, uniforms, health insurances, excursions, pocket money, ski rentals, exam fees, entry fees public domains.
- 1.4 Elective courses: Advanced Preparation Program for the admission into Swiss public high schools : CHF 2'000.- / year. Mathematics, French, German, Special Option (law and economics).
- 1.5 Scholarships (MATEA) and financing plans : upon request.

2. French immersion / study abroad and short stay fees :

Package fees : 2 to 4 weeks : CHF 1'650.- / weeks, 5 to 8 weeks : CHF 1'500.- / weeks, > 8 weeks: ask for a proposal.

- 2.1 Included : full board, courses and material, all activities transports and airport transfers.
- 2.2 Not included: private courses, pocket money, assurances (+ CHF 4.- / day), ski Pack (+ CHF 300.- / days : Swiss Ski School, rentals, skilifts).

3. Conditions générales :

The first payment of CHF 1'500.- covers the fixed admission fee and guarantees the reservation of your child's place. This amount is non-refundable and is not deducted from tuition fees.

Tuition and board, as well as variable fees deductible from the child's personal deposit, will be paid separately in accordance with the approved payment plan. The early departure of a pupil must be notified in writing 3 months in advance, otherwise the following semester is due in its entirety.

Payments made in advance will not be refunded in the event of cancellation, early departure or dismissal of the student. In case of late payments, the school reserves the right to refuse the student.

The admission of a student to Chantemerle implies the acceptance of the financial conditions by the parents or the legal representative. Chantemerle reserves the right to change tuition fees. In case of dispute, the competent jurisdiction is Vevey.
